1. Consent Statement under the Brazilian General Data Protection Law (LGPD)

Nêmesis Investimentos (“Nêmesis”, “we”, “us”) is committed to safeguarding your privacy in the course of this relationship. This Privacy Policy describes how we collect, use, store, share, and protect the personal data of the users and visitors of our website, in accordance with Brazilian Federal Law No. 13,709/2018 (the General Data Protection Law — LGPD).

By using our website and our services, you agree to the collection and processing of personal data as described in this Policy.

2. Data We Collect

Depending on how you interact with our website, we may collect the following categories of data:

- Identification and contact data you provide, such as name, e-mail address, phone number, and company, when completing contact forms, registration forms, or information requests;
- The content of communications exchanged with our team (e-mails, forms, messages);
- Browsing data, such as IP address, browser type, pages visited, and cookies (where applicable).

We do not collect payment data or credit/debit card information, as our website does not process sales or commercial transactions directly with users.

3. Purposes: How We Use This Information

We use the data we collect to:

- Provide, improve, and develop the services and content available on our website;
- Respond to inquiries, questions, and contact requests;
- Comply with applicable legal, regulatory, or tax requirements;
- Send institutional communications, where you have consented to receive them.

4. Data Sharing

We do not sell or rent your personal data to third parties. We may share personal data in the following circumstances:

- With service providers who assist us in operating the website (for example, hosting and technology infrastructure providers), always limited to what is necessary to provide the service;
- When required by law, court order, regulatory authority, or competent government agency.

5. Where We Store and Process Your Data

The data we collect is stored and processed on the servers of hosting providers engaged by Nêmesis, using technical and organizational measures consistent with market best practices for data protection.

6. Controller Responsibilities and Security Measures

We adopt technical and administrative measures to protect personal data against unauthorized access, loss, alteration, or improper disclosure. All traffic between your computer and our servers is encrypted using a secure SSL protocol or equivalent.

7. How Long We Retain Your Information

We retain the information we collect for as long as necessary to fulfill the purposes described in this Policy, or until you request the permanent deletion of your data, subject to retention obligations required by law or for the exercise of legal rights.

9. Data Subject Rights

Under the LGPD, you have the right to:

- Portability of your data to another service or product provider;
- Deletion of personal data processed with your consent;
- Information about the entities with which we share your data;
- Withdrawal of consent at any time.
